
What has changed, and why.

Firearms Amnesty - Mobile

Between August and September, people in Southern, Northern and North West of Tasmania surrendered over 70 firearms.

"It's pleasing that over the last three weekend, Tasmanians have taken the opportunity to surrender firearms to police at mobile amnesty locations across the State".

"At mobile firearms amnesty days in Bridgewater and Glenorchy, 21 unregistered firearms and a quantity of ammunition were surrendered to police", said Senior Constable Paul Hyland.



It is important to remember that under Tasmanian permanent amnesty, people can surrender illegal and unwanted firearms, firearm parts, ammunition, or gel blasters that imitate a firearm, without being prosecuted.

A message from the Manager

In the next few weeks Firearms Services will commence using new application and renewal forms. They have changed substantially and you will notice this when you come to use the new form.

Often in the past, requesting additional information meant substantial delays to the process. Ultimately, the new forms seek to collect new information that we hope will speed up our processing times.

Collecting this important information on the forms should speed up the process by days, if not weeks. Of course, if the information is not volunteered at the time of completing the forms, the usual delays will result. At least this way it won't impact those that do the right thing other than in a positive

Never assume Firearms Services have the information already, this will cause you not to complete a form correctly. Each form, each time is a separate application to either renew a licence or to apply for a licence. The form should be completed with full disclosure on each occasion.

Where people omit things from their form it has the effect of being interpreted as a deliberate attempt to withhold important information. I recommend full disclosure, it positions the applicant as a person that is acting with honesty and integrity.

In closing, I wish to thank the clubs and their committee members, range officers etc for supporting members in their compliance with safety standards and the Firearms Act while at your facilities.

Upcoming changes to the Firearms Licence Application Form and Firearms Renewal forms

From late 2023, Firearms Services will be sending out new renewal application forms to those licence holders required to renew their firearms licence.

Additionally, those wishing to apply for a new licence will be able to download the updated form from our website, or contact us to have one posted.

Changes to the Firearms Licence Application:

- New questions about interstate and international living
- New questions about firearms possession interstate and internationally
- New questions about criminal history
- New questions about mental and physical health
- New advice regarding storage of firearms

Changes to the Firearms Renewal Application:

- New questions about criminal history
- New questions about mental and physical health
- New questions about storage
- Updated Genuine Reason and Proof section

As the regulator of the *Firearms Act 1996*, Firearms
Services are required to ensure that all applicants are
assessed on correct and true information provided by the
applicant or the licence holder, for the purpose of being
'fit and proper'. Therefore, there will be a new paragraph
on the front page of both the Firearms Licence
Application and Firearms Licence Renewal Forms:

"It is an offence for a person, in making an application or providing information, to either make a statement knowing it to be false or misleading or to omit any matter knowing that without that matter, the application or information is false or misleading.

Doing this is both an offence pursuant to Section 126 of the Firearms Act 1996 and a basis to **refuse an application** for a firearms licence or **cancel an existing firearms licence**.

Penalty: Fine not exceeding 100 penalty units or imprisonment for a term not exceeding 3 years, or both".
